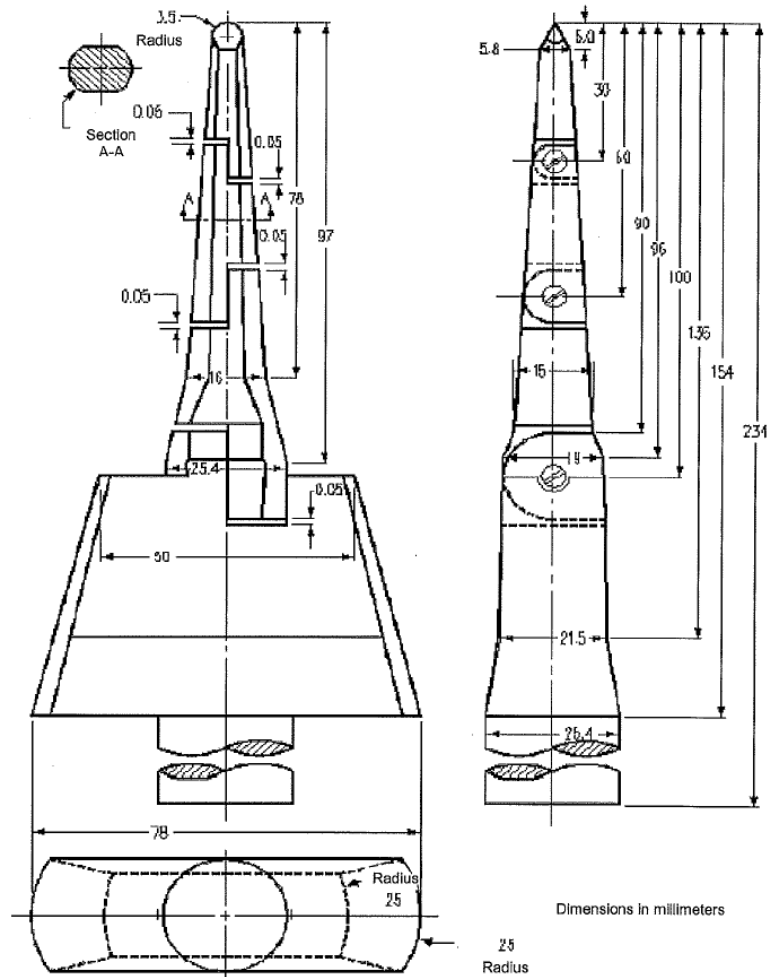


Figure JA.1 Test finger

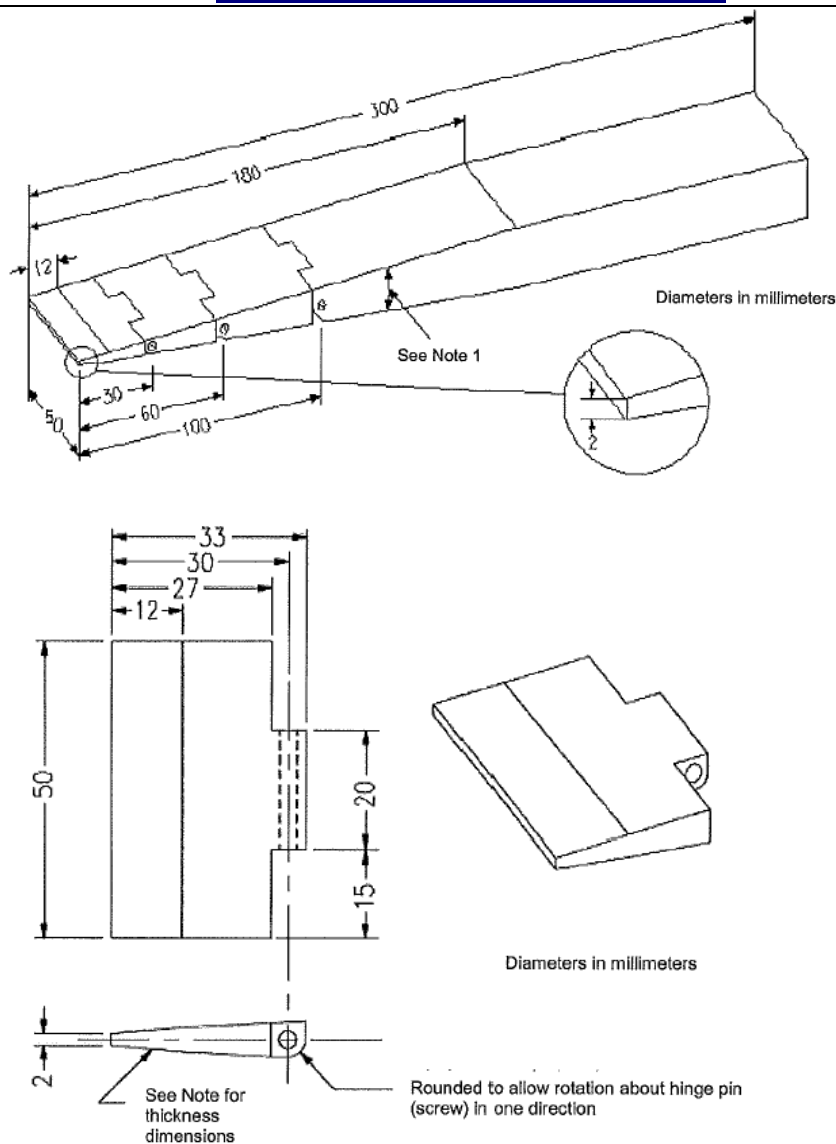
