



#### General product information and other remarks:

The equipment under tests is a Class II ICT/ITE POWER SUPPLY, designed for audio/video, information technology equipment and indoor use only.

External enclosure is made of min. V-0 plastic material. Two pieces of enclosure are enclosed with ultrasonic welding without screw.

The equipment uses replaceable plug part. Only Europe plug has been evaluated and compliance by EN50075. Other plugs should be checked when marketed in country.

Explanation of model designation GTX41060ZWWVV-X.X:

First X: can be "M" or "-" for market identification and not related to safety.

Z: can be - or CC, "-" = Constant Voltage Model, CC = Constant Current Model WW: rated output wattage, maximum 25

VV: rated output voltage, with a range of 3-30

-X.X is optional or blank, denotes the output voltage differentiator, subtracting or adding X.X volts from standard output voltage VV in 0.1V increments. VV-X.X together denotes a voltage range of 3-30Vdc.

Maximum rated output current is 3.00A

All models are identical except minor differences in transformer secondary winding and secondary circuit

The models GT-41060-1505 and GT-41060-2530 represent the worst case because the models have highest V, A and VA
