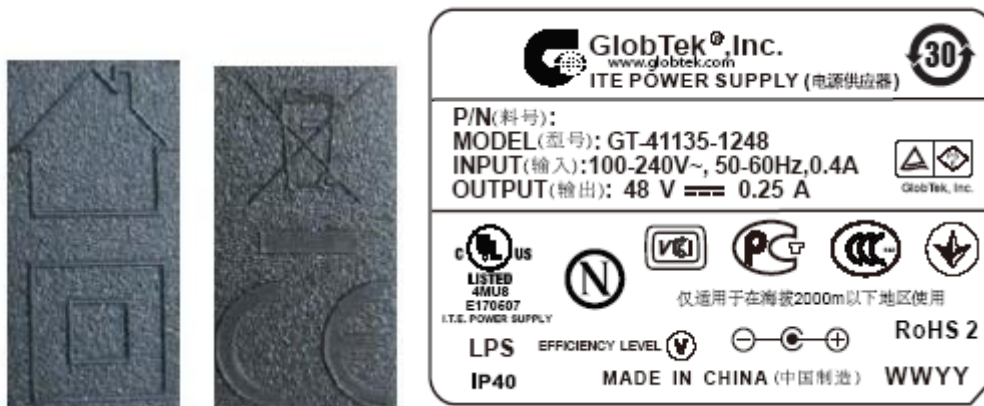

The equipment under test is a class II switching power adaptor for ITE and indoor use only. External enclosure is made of min. V-1 plastic material. Two pieces of enclosure are enclosed with ultrasonic welding without screw.

The equipment uses replaceable plug part. Only Europe plug have been evaluated and compliance by EN50075.

Explanation of model designation GT-41135-WWVV-X.X:

"WW" is the rated output wattage designation, with a maximum value of "12".

"VV" is the standard rated output voltage designation, with a maximum value of "48".

"-X.X" is optional or blank and denotes the output voltage differentiator, subtracting or adding X.X volts from standard output voltage VV in 0.1V increments. VV-X.X together denotes a voltage range of "5-48"Vdc.

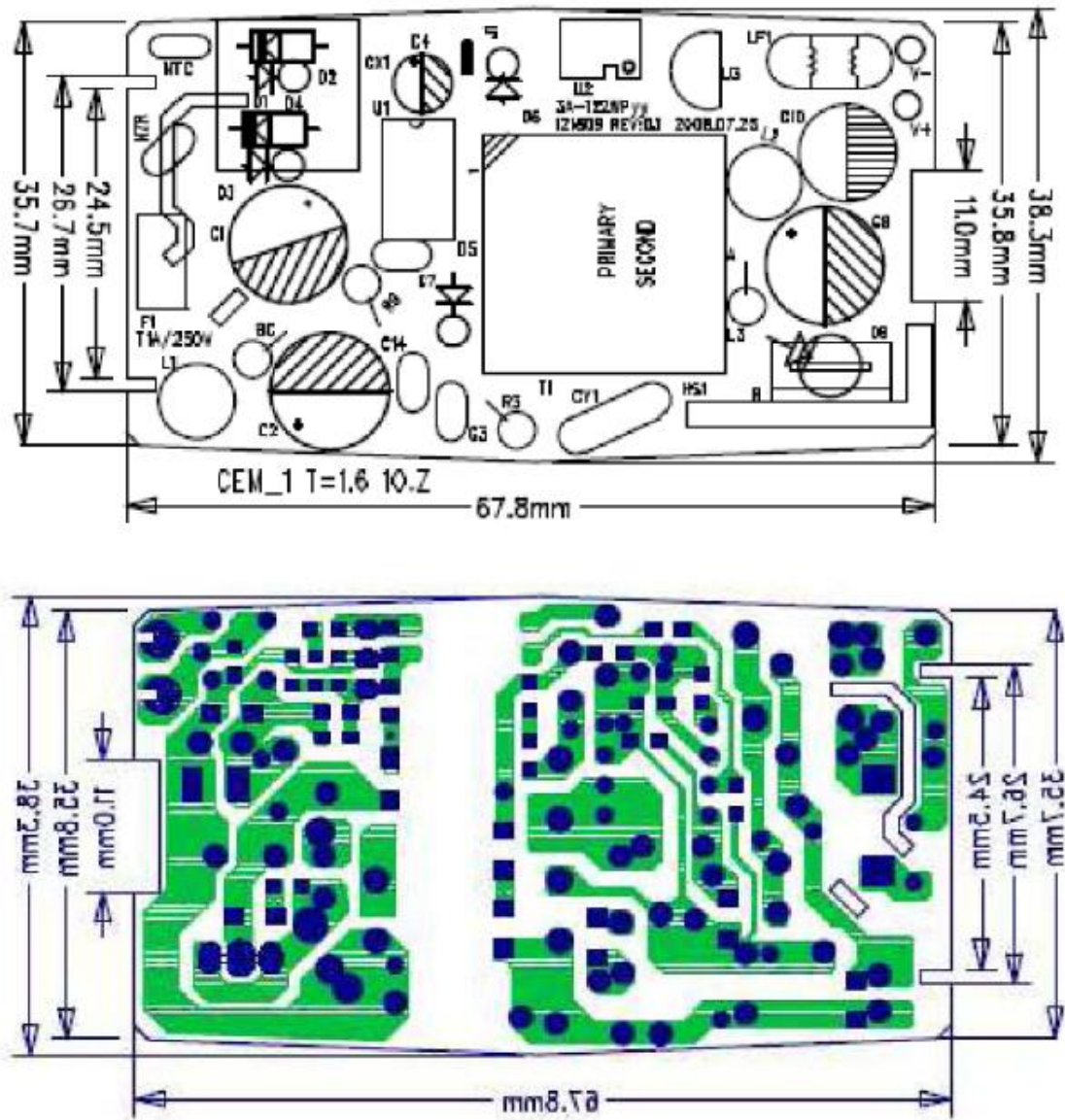
